### Own Damage & Theft (OD/T)

It covers partial or total loss of the car/vehicle caused by accidental collision or overturning, fire, external explosion, self ignition or lightning or burglary, housebreaking or theft, malicious act, or whilst in transit incidental to such transit by road, rail, inland waterway, lift or elevator.



### Acts of Nature (AON)

It covers partial or total loss of the car/vehicle caused by any natural disasters that we cannot foresee or prevent including typhoon and flooding, earthquakes, tornadoes, volcanic eruption, and any other naturally occurring catastrophe.



### Excess Third Party Bodily Injury (ETP-BI)

In excess of the limit cited under the Compulsory Third Party Liability, the insurer pays all sums, within the limits set forth in the schedule of indemnities, to discharge the liability of the insured to a third party for bodily injury.



### Third Party Property Damage (TP-PD)

Similar to Item ETP-BI, it affords protection to the insured against liability to a third party for property damage.



### Auto Personal Accident for Passengers (Auto-PA)

It gives protection to the passengers of the insured car/vehicle for bodily injury or death resulting from an accident.
