copy annexed, adopted on August 10, 2016 by majority vote of the Board of Directors and on September 14, 2016 by the vote of the stockholders owning or representing at least two-thirds of the outstanding capital stock, and certified under oath by the Corporate Secretary and a majority of the Board of Directors of the corporation was approved by the Commission on this date pursuant to the provision of Section 16 of the Corporation Code of the Philippines, Batas Pambansa Blg. 68, approved on May 1, 1980, and copies thereof are filed with the Commission.

Unless this corporation obtains or already has obtained the appropriate Secondary License from this Commission, this Certificate does not authorize it to undertake business activities requiring a Secondary License from this Commission such as, but not limited to acting as: broker or dealer in securities, government securities eligible dealer (GSED), investment adviser of an investment company, close-end or open-end investment company, investment house, transfer agent, commodity/financial futures exchange/broker/merchant, financing/lending company and time shares/club shares/membership certificates issuers or selling agents thereof; nor to operate a fiat money to virtual currency exchange. Neither does this Certificate constitute as permit to undertake activities for which other government agencies require a license or permit.

AMENDED ARTICLES OF INCORPORATION

OF

ALLIEDBANKERS INSURANCE CORPORATION

KNOW ALL MEN BY THESE PRESENTS:

That we, all of legal age, residents and a majority of whom are citizens of the Philippines, have this day voluntarily associated together for the purpose of forming a non-life insurance corporation under the laws of the Republic of the Philippines.

AND WE HEREBY CERTIFY THAT:

FIRST:

That the name of the corporation shall be:

"ALLIEDBANKERS INSURANCE CORPORATION"

SECOND:

That the purposes for which said corporation is formed are:

PRIMARY PURPOSE

1. To engage on the business of insurance and Guaranty in any branch except in Life Insurance, for consideration, to indemnify any person, firm or corporation against losses, damages or liabilities arising from an unknown or contingent event, and to guarantee liabilities and obligations of any person, firm or corporation, and to act as agent of other Insurance or Surety Companies, in any of their branches, including Life Insurance.

SECONDARY PURPOSES

- 1. Subject to law and the consent of the necessary stakeholders, to acquire the property, rights, privileges, franchise, liabilities and business of AlliedBankers Insurance Corporation, a corporation incorporated under the laws of the Republic of the Philippines with SEC Registration No. 16974 and which is in the process of liquidation.
- 2. To insure houses, tenements, merchandise and all other properties and effects, real or personal, against loss or damage by fire, storm, earthquake, fire resulting from earthquake, accident or otherwise, and to carry on the ordinary business fire insurance in all the aforesaid branches; to rebuild, repair, replace or reinstate houses, buildings, tenements and every other description of property which may be insured by the corporation, and to carry on any kind of business necessary or expedient for any such purpose.

- 3. To insure against every description of Marine risks which may legally be undertaken relating to the peril of the sea, fire, war, reprisal and other risks like nature incidental to the seas, ships, vessels and water-craft of all description, and the freight, goods, merchandise, cargo and all property whatsoever in or on board the same; to insure all other matters and things which may lawfully be, from time to time, insured or be the subject matter against marine risks and perils of the sea.
- 4. To grant policies or other instruments or assurance against, or to issue insurance for compensation or payment in case of death or injury to health or limb by railway or airplane accident or shipwreck or other peril of land, sea or air, or any accident or misadventure or violence during any journey or voyage by land, water, sea or air, or any similar perils, for a limited or specified period, and to prepare, provide or supply medicine and surgical aid and treatment or any other assistance and remedy or needful requirement in case of accident or harm to the person so injured.
- 5. To re-insure all or any risks of the corporation and to undertake all kinds of the re-insurance and counter-insurance connected with the business of any other company.
- 6. To guarantee the fidelity of persons holding places of public or private trust and to agree to the faithful performance of any contract or undertaking made with any public authority.
- 7. To guarantee the performance of contracts or agreements, undertakings, obligations, promises or duties of all kinds other than insurance policies.
- 8. To guarantee the performance of insurance contract where surety bonds are accepted for such purpose.
- 9. To execute and guarantee bonds and undertakings of all kinds, required or permitted to be taken in any or all actions, proceedings, negotiations, importations or exportations, or any other transactions or operations, either by private individuals or entities, or by heads of departments or offices, courts, judges, officers, boards or bodies, whether executive, legislative or judicial.
- 10. To guarantee and to indemnify merchants, traders and those engage in business and giving credits, from loss or damage by reason of giving and extending such credit to their customers or persons dealing with them.
- 11. To indemnify against loss by burglary, theft, forgery, embezzlement or buy one any or more of such happenings.
- 12. To insure glass and sheet glasses against breakage.
- 13. To guarantee and to indemnify the owners and users of steam boilers and pipes, of fly wheels, engines of all kinds of machineries, especially motor cars and other conveyances for transportation, against explosion or other accidents and against loss or damage to life or property resulting therefrom, and against loss or use of occupancy caused thereby, and against liability unto third persons by way of said causes; and to make inspection upon, such boilers, pipes, fly wheels, engines and machineries.

- 14. To execute, sign and carry out fidelity bonds and surety undertakings of every nature and kind usual in the business of fidelity and surety companies, or permitted by law unto such companies.
- 15. To lend money on such terms as may soon expedient, subject to the requirement of law.
- 16. To purchase or otherwise acquire and undertake all or any part of the business, property and liability of any person or company carrying on any business which this corporation is authorized to carry on, or any property suitable for the purposes of this corporation.
- 17. To acquire by purchase and invest in, hold, sell or otherwise dispose of the stock or bonds, or any interest in either, or any obligations or evidence of indebtedness, of any corporation, domestic or foreign, or the bonds or other obligations or evidences of indebtedness, of any person, firm or corporation, and while the owner of such stocks, bonds or interest therein or other obligations or evidences of indebtedness, to exercise all the rights, powers and privileges of ownership, including the right to vote thereon or consent in respect thereof for any and all purposes as allowed by law.
- 18. To purchase or otherwise acquire, sell lease, convey, mortgage, encumber and otherwise deal with any other property or interest therein, or easement, right or privilege over or in respect of any property, real or personal as may be permitted by law and as may be reasonably necessary to enable it to carry out the purposes for which the corporation is created as may now or hereafter be allowed by laws.
- 19. To procure the corporation to be registered or recognized or to be permitted or allowed to carry on its business or any breach or breaches hereof in any state, territory, or possession of the United States or in any other foreign country or place; and in carrying on its business to do any and all powers which a natural person can do or exercise which now hereafter may be authorized by law.
- 20. To do all or any of the other things as principals, agents, contractors, trustees or otherwise, and by or through trustees, agents or otherwise and either alone or in conjunction with others, to the extent allowed by law.
- 21. To do such all other things as are incidental or conducive to the attainment of the above objects.
- 22. To do and perform any and all of the acts and thirgs to exercise all of the general powers conferred by law upon corporation similarly organized and usually and ordinarily incidental to companies of like nature and kind.

THIRD: That the place where the principal office of the corporation is to be established is at 17th Floor Federal Tower, Damariñas Street corner Muelle de Binondo, Binondo, Manila

FOURTH: That the term for which the corporation is to exist is FIFTY (50) years from and after the date of issuance of the certificate of incorporation.

SEVENTH: That the amount of authorized capital stock of said corporation is ONE BILLION PESOS (P1,000,000,000.00), Philippine Currency, and said capital stock is divided into ONE BILLION (1,000,000,000) shares with a par value of ONE PESO (P1.00) per share. (As amended by a majority vote of the Board of Directors in its meeting held on 10 August 2016 and by the Stockholders representing at least two-thirds (2/3) of the outstanding capital stock of the Corporation in a meeting held in the same city as the principal office of the Corporation on 14 September 2016).

(As further amended by a majority vote of the Board of Directors in its meeting held on 12 October 2016 and by the Stockholders representing at least two-thirds (2/3) of the outstanding capital stock of the Corporation in a meeting held in the same city as the principal office of the Corporation on 14 December 2016).

The holders of shares of the corporation shall have no pre-emptive right to subscribe to or purchase any shares of stock of the corporation of any class now or hereafter authorized, issued or reissued from treasury. (As amended by a majority vote of the Board of Directors in its meeting held on 10 August 2016 and by the Stockholders representing at least two-thirds (2/3) of the outstanding capital stock of the Corporation in a meeting held in the same city as the principal office of the Corporation on 14 September 2016).

EIGHT: The amount of capital stock which has been actually subscribed is Three Million Four Hundred Fifty Thousand (3,450,000) shares representing the sum of Three Hundred Forty Five Million Pesos (PhP345,000,000.00) and the following persons have subscribed for the number of shares and the amount of capital stock set out after their respective names:

TENTH: That JUANITA TAN LEE has been elected by the subscriber as Treasurer of the corporation to act as such until her successor is duly elected and qualified in accordance with the By-Laws and that as such Treasurer, he has been authorized to receive for and in the name and for the benefit of the corporation, all subscriptions paid by the said subscribers.

ELEVENTH: That the incorporators, hereby undertake to change its corporate/partnership name immediately upon receipt of notice or directive from the Commission that another corporation, partnership or person has acquired a prior right to the use of that name or that the name has been declared as misleading. Deceptive, confusingly, similar to a registered name, or contrary to public morals, good custom or public policy.
